

**CITY OF MUSKEGO  
NOTICE OF PUBLIC HEARING**

PLEASE TAKE NOTICE that the Common Council of the City of Muskego will hold a Public Hearing at 7:25 PM on Tuesday, May 27, 2003 in the Muskego Room of City Hall, W182 S8200 Racine Avenue, to consider the termination of a conditional use permit in accordance with Section 6.03(E) of the Zoning Code, for an illuminated outdoor recreation facility for the former Moose Lodge parcel located at the southeast corner of Janesville and Crowbar Roads in the SW ¼ of Section 18 (Tax Key No. 2231.995)

The subject property is zoned B-2/OHS Local Service Center as modified by the Highway Service Overlay District and B-2 Local Service Center District has a conditional use grant to permit the operation of illuminated outdoor recreation facility, specifically illuminated horseshoe pits. The subject property is currently vacant. Section 6.03(E) of the Zoning Code states:

"Termination: Where a permitted conditional use does not continue in conformity with the conditions of the original approval, or where a change in the character of the surrounding area or of the use itself causes it to be no longer compatible with surrounding areas, or for similar cause based upon consideration for the public welfare the conditional grant may be terminated by action of the Common Council following referral to the Plan Commission for recommendation, and public hearing thereon. Such use shall thereafter be classified as legal nonconforming use, except that where the action is due to failure to comply with the conditions of the conditional grant, the Common Council may require complete termination of such use."

Detailed descriptions are available for public inspection at the City of Muskego Planning Office. All interested parties will be given an opportunity to be heard.
