NOTICE OF PUBLIC HEARING**

PLEASE TAKE NOTICE that the Common Council of the City of Muskego will hold a Public Hearing at 7:00 PM on Tuesday, January 13, 2003 in the Muskego Room of City Hall, W182 S8200 Racine Avenue, to consider a 90 day extension to the existing moratorium on Land Divisions, Rezoning Petitions, and the approval of Building Site and Operation (BSO) Plans. Said moratorium to apply to the following parcels as identified by Tax Identification Number and illustrated on the map attached hereto, which are currently zoned RS-1 Suburban Residence District and RSE Suburban Estate District:

The preliminary results of the City's Economic Development Study finds that residential development, as depicted in the adopted 2010 Comprehensive Plan, may not be the highest and best use of the subject lands. The purpose of said moratorium is to ensure time for the City of Muskego Plan Commission and Common Council to: (1) study and approve possible amendments to the adopted Comprehensive Plan; (2) study and approve possible amendments to Chapter 17 of the Municipal Code pertaining to zoning regulations, and (3) study and approve possible amendments to the zoning map of the City of Muskego. All interested parties will be given an opportunity to be heard.
