Upon the petition of Lettys Bertram shall the following described area (Also known as Lot #2 of the proposed CSM):

All that part of the Southwest Quarter (SW 1/4) of the Northeast Quarter (NE 1/4) of Section 30, Town 5 North, Range 20 East, City of Muskego, Waukesha County, Wisconsin, bounded and described as follows: Commencing at the southeast corner of said Northeast Quarter (NE 1/4); thence South 88°02'28" West along the southerly line of said Northeast Quarter (NE 1/4) 1339.085 feet to the place of beginning of the land hereinafter described: thence continuing South 88°02'28" West along said southerly line and center line of Parker Road 300.00 feet; thence North 02°09'43" West 620.810 feet; thence North 88°02'28" East 300.000 feet to a point on the west line of the East Half (E 1/2) of said Northeast Quarter (NE 1/4); thence South 02°09'43" East 620.810 feet to the place of beginning, containing 4.2755 acres of land.
