The Comprehensive Planning Committee has been working on the new 2020 Comprehensive Plan over the past two years. The 2020 Plan is a revision to the City's current 2010 Comprehensive Plan and meets the State's Smart Growth Statutes.

The Comprehensive Plan is the document by which the citizens of the City of Muskego, through the Comprehensive Plan Committee, express their long-term vision, goals, and objectives with respect to the overall quality of life in Muskego. A variety of topics are included in the plan consisting of the following: Housing, Transportation, Utilities/Community Facilities, Agricultural/Natural/Cultural Resources, Economic Development, Intergovernmental Cooperation, and Land Use.

The public is invited to view the plan and maps between 6 PM and 8 PM. City staff will provide an overview presentation on the proposed plan beginning at 6:00 PM. Staff and 2020 Plan Committee members will be on hand after the presentation until 8 PM to answer any questions or concerns you might have.
