**PLEASE NOTE SPECIAL INSTRUCTIONS AND INFORMATION
REGARDING TAXES AND DOG LICENSING**

- 1) In order to serve our customers more efficiently, please be courteous when paying taxes in person, and have your check completed before stepping up to the window. If you are not ready, we will ask you to step aside, in order to assist others that are ready.
- 2) Please **DO NOT PAY** your taxes if your mortgage company is paying them directly, as this creates unnecessary work and confusion. While the City of Muskego does not provide income tax advice, it is our belief that your deduction is valid when you give up control of your funds. Please check with your tax advisor regarding this. Example of giving up control would be your mortgage escrow statement showing the amount and date removed from your escrow account. The City will not endorse escrow checks over to the taxpayer.
- 3) To check the amount of your tax bill or to check if payments have been made, you can access that information at <http://www.WaukeshaCounty.gov>.

If you need to contact City Hall for tax payment information, call (262) 679-4103. Your call will be sent to a voice mailbox. Please leave your name, address of the property, tax key number, if available, and a daytime phone number. Calls will be returned in the afternoon, when all payments received by mail have been processed for the day.

- 4) **Dog licenses** will not be issued at the Clerk-Treasurer's office from December 10 through January 31. The enclosed form should be completed, along with proof of rabies vaccination and returned to City Hall for processing. Or, to renew a current dog license on line, go to www.ci.muskego.wi.us, click on payments (no service charge applies). The 2010 license, and metal tag will be mailed to you after February 15, 2010
- 5) Breakdown of tax dollars shown in a Pie Chart format will be available at the Clerk-Treasurer's office and on the City of Muskego website at www.ci.muskego.wi.us click on Taxes

TAX PAYMENT DUE DATES –FOR REAL ESTATE TAXES ONLY

Payment in full or 1 st Installment due:	January 31, 2010
Second Installment due:	April 30, 2010
Third Installment due:	July 31, 2010

NOTE: If any installment is not paid by the due date, the installment option is lost and the entire unpaid balance is delinquent and subject to interest and penalty of 1.5% per month from February 1, 2010.

PROPERTY OWNERS MUST FORWARD THEIR OWN TAX BILLS TO THEIR LENDERS**Payment Information:**

- Make check payable to the CITY OF MUSKEGO (include Tax Key No. on check).
- Return **TOP** portion of tax bill with bar code, and mail with your payment in envelope provided.
- To obtain a receipt, a stamped, self-addressed envelope must be provided.
- Any refund due will be mailed within three weeks of receipt of payment.
- Escrow checks made payable to the property owner must be endorsed by all parties.

PAYMENTS ACCEPTED AT BANKS IN DECEMBER ONLY (In-lobby service only - no drive-through)

- The **Banks** will not issue receipts or process refunds.
- The **City** will mail a receipt ONLY if a stamped self-addressed envelope is submitted.
- The **City** will mail all refund checks within three weeks of receipt of payment.
